



Double Degree Agreement

Between
Providence University (PU)
And
Mulawarman University(UNMUL)

1. Providence University, TAIWAN, represented by the president of Providence University, hereinafter referred to as "PU"

2. Mulawarman University Samarinda, East Kalimantan, (INDONESIA), represented by the Dean of Faculty of Economics and Business, Mulawarman University Samarinda, East Kalimantan, INDONESIA) hereinafter referred to as "FEB UNMUL"

building on: The Memorandum of Understanding, signed by Providence University and FEB Mulawarman University, establishing mutual contribution to the academic education encouraging exchange of students.

wishing: to establish a double-degree-programme allowing students of Providence and of the FEB Mulawarman University to achieve a master's degree at the partner university in addition to the degree of the home university, agree on the following provisions:

1. Degrees

Master students of Providence University as their home university will obtain a master's degree in business management at the FEB of Mulawarman University and a master's degree in Business Administration at Providence University, when they have successfully completed the double degree programme.

Master students of Mulawarman University as their home university will obtain a Master's degree in Business Administration at Providence University and a master's degree at the FEB of Mulawarman University, when they have successfully completed the double degree programme.

2. Acceptance of students:

PU and FEB UNMUL plan to enter into partnership for the purpose of offering UNMUL FEB students an opportunity to complete double degree programmes in two years. Based on the mutual consent, FEB UNMUL is encouraged to send maximum 10 students during the period of the agreement. The number of tuition waived students each year entering the double degree programmes will be limited to 5. Extension of the programme is possible by mutual consent of both parties.

The FEB of Mulawarman University agrees to accept double degree students from Providence University on the condition that they:

- a) are nominated by Providence University.
- b) have BA degree and one year of GMBA study at Providence University respectively. The specific requirements for admission to UNMUL are given in the Admission brochure
- c) have reached a minimum GPA of 3.0 in Taiwan standard
- d) are able to follow courses in English (TOEFL iTP550, IELTS6.0 or equivalent, oral interview is required)

Providence University agrees to accept double degree students from Mulawarman University on the condition that they:

- a) are nominated by Mulawarman University
- b) have finished a Bachelor degree. The specific requirements for admission to Providence are given in the Admission brochure.
- c) have reached a minimum GPA of 3.0 (on a 4.0 scale-based)
- d) are able to follow courses in English (A TOEFL iTP 550, IELTS6.0 or equivalent, oral interview is required)

This general agreement does not exclude the university's right for a case by case decision.

3. Guest lecturers

Both partner institutions will encourage guest lecture of professors from Partner University in their curricula.

4. Organization of double degree programmes

Providence University will send to FEB Mulawarman University for each double degree student:

- a copy of the BA diploma or certificate or equivalent
- transcript of all acquired subjects
- a statement that all requirements for admission to the programme are fulfilled
- before graduation, a certificate that the student has submitted and successfully defended master's thesis at the Providence University.

The master's thesis should be directed and approved by the student's advisors from PU and approved by co-advisors from the FEB UNMUL.

(The advisors must, at least have academic qualification as Assistant Professor or alternatively Lecturers with a PhD degree)

FEB UNMUL will send to PU for each double degree student:

- a copy of Bachelor Degree certificate or equivalent
- a copy of the transcript for all courses taken at the FEB UNMUL
- a statement that all the requirements for admission to the programme are fulfilled
- before graduation, a certificate that the student has submitted and successfully defended master's thesis at the FEB UNMUL.
- The master's thesis should be directed and approved by the student's advisors from the FEB UNMUL and approved by co-advisors from the PU.
 - (The advisors must, at least, have academic qualification as Assistant Professor, or alternatively Lecturers with a PhD degree)

5. Study period and Credits

PU students to FEB UNMUL:

(1) Students that have fulfilled all the prerequisites will study for at least one semester at UNMUL where they will follow the MBA program or any other program in English.

FEB Unmul students to PU:

- (1) Students that have fulfilled all the prerequisites will study for at least one semester at PU, where they will follow the Global Master of Business Administration program-GMBA (or other master studies available).
- (2) The minimum required credits should reach minimum one third of the total credits (37 credits) and 6 credits in thesis. Namely, students should take at least 12 mandatory/elective credits and thesis.

If less than 5 candidates are selected for the Double-degree programme; the partner institutions can choose to send students for credit only instead (one double degree student being equivalent to 2 students studying for one semester each).

6. Student Expenses

Students that selected in the programme are required to pay their tuition fees at their home university accordingly. No tuition fees will be charged by the receiving institutions.

Expenses related to the travel, living cost, insurance, miscellaneous and other facilities, in the host country will be the responsibility of the participating student. Providence University and Mulawarman University may support and scholarships for double degree students.

7. Duration of the Letter of Agreement

This Double Degree Agreement will come into force from the date of its signed and will be valid for the duration of five years. Parties will evaluate this Letter of Agreement at least one year prior to the end date and will then decide whether this Letter of Agreement will be roll-over under conditions to be agreed upon. Alterations and additions to this agreement must be in writing.
